1. This invitation for expression of interest follows the General Procurement Notice (GPN) which appeared in Daily News Issue No. 12011 dated 14<sup>th</sup> August, 2017.
2. The Tanzania Electric Supply Company Limited (TANESCO) has set aside funds for the operation during the financial year 2017/18. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for which this invitation is issued.
3. TANESCO now invites eligible consultant firms to express their interest in providing the services which include Provision of Consultancy Services for Design of Main Valve/ Cylinder Gate for Each unit G1, G2&G3 at Kihansi Hydro Power Plant.
4. Interested consultant firms must provide information indicating that they are qualified to perform the services by:-
  - a) Submitting Consultant's profile indicating registration in Electromechanically or Civil Works or Both in Hydropower Plant;
  - b) Indicating Similar assignments relating to Major electromechanical equipment and civil work in Hydro Power Plant;
  - c) Indicating experience of at least 5 years in design, installation, major repair/ overhaul and construction of underground Power Plant and tunnel designs etc;
  - d) Availability of appropriate skills among staff, equipment etc;
  - e) Construction may associate to enhance their qualification;

NB: Qualified Consultancy firms with at least 5 years' experience working in similar assignment especially on Pelton Turbine with not less than 850 meters ahead will be highly considered.

Tendering will be conducted through the International Competitive Selection and the consultant(s) will be selected in accordance with the procedures set out in the Public Procurement Regulations, 2013 – Government Notice No. 446 read together with Public Procurement (Amendment) Regulations, 2016 G.N No. 333 (hereinafter called Procurement Regulations).
6. Selection will be conducted through the Quality and Cost based selection procedures specified in the Public Procurement Regulations.
